

# **NEBRASKA ONE BOX PHEASANT HUNT PAST SHOOTER HALL OF FAME**

## **1. ELIGIBILITY:**

Any member of the community who has made a significant contribution to the success of the Nebraska One Box Pheasant Hunt, or anyone who has been a past shooter for at least five years and has demonstrated good sportsmanship through his participation in the One Box Pheasant Hunt shall be eligible for membership in the Past Shooters Hall of Fame.

## **2. NOMINATIONS:**

Any Past Shooters may nominate a candidate, or candidates, for consideration by the Hall of Fame Selection Committee

## **3. NOMINATION PROCESS:**

(a) All nominations must be in writing and submitted to the Past Shooters Hall of Fame Selection Committee by June 30<sup>th</sup> of each year for consideration by the Hall of Fame Selection Committee prior to the September meeting of the Past Shooters Board of Directors.

(b) Nominations must briefly describe the contributions through dedication, interest, and sportsmanship the candidate has made to the perpetuation and success of the One Box Pheasant Hunt. Nominations may state any other reasons why the candidate should be considered for membership in the Past Shooters Hall of Fame.

(c) Contributions to the perpetuation and success of the One Box Pheasant Hunt may be in the form of any one, or combination of the following:

- (1) direct or indirect financial support of the hunt or any of the One Box activities;
- (2) membership on the One Box Board of Directors, Past Shooters Board of Directors, or the Foundation Board of Directors;
- (3) the devotion of time to any special project or event that has in the past, or will in the future directly benefit any of the One Box activities;
- (4) the devotion of time to the administration of any of the various hunt activities and functions or the operations of the hunt in general
- (5) loyalty and devotion to the overall success of the hunt

## **4. HALL OF FAME COMMITTEE:**

The Hall of Fame Committee shall be made up of the Past President, President, and one current member of the Past Shooters Board of Directors. The director at large shall be appointed by the president on an ad hoc basis. All nominations shall be reviewed by the Hall of Fame Committee prior to the September meeting of the Board of Directors. The Hall of Fame Committee shall determine whether the candidate meets the criteria for submission to the Past Shooter Board of Directors for election to the Hall of Fame.

## **5. SELECTION PROCESS:**

(a) The secretary shall maintain an on-going list of all qualified candidates who have been submitted to the Board of Directors for election to the Hall of Fame.

- (b) At each September meeting of the Past Shooters Board of Directors, the secretary shall present a ballot containing the names of all the qualified candidates for election to the Past Shooters Hall of Fame.
- (c) All officers and directors present at the September meeting of the Past Shooters Board of Directors shall be entitled to vote. There shall be no proxy of absentee votes.
- (d) Voting shall be by secret ballot. Voting shall be in the form of a “yes”, “no”, or “abstention” vote for membership in the Past Shooters Hall of Fame.
- (e) A 2/3 “yes” vote of all ballots cast shall be required for membership in the Past Shooters Hall of Fame. The secretary shall count the votes and announce the results before the meeting is adjourned. The secretary shall record only the names of the successful candidates in the minutes of the Board of Directors.
- (f) The secretary shall remove from the on-going list of candidates the name of any candidate who has failed to be elected to the Hall of Fame after three votes. The candidate may be re-nominated for membership at any time into the Hall of Fame.

**6. ANNOUNCEMENT:**

The names of the new members to the Past Shooters Hall of Fame shall be announced at the Saturday night Victory Banquet of the annual One Box Pheasant Hunt.
